Presentation from RC and SG on the Hospital Infrastructure Plan (HIP2) KGH Redevelopment:	
A presentation was given showing that there is a three-stage approval process for this redevelopment. The first stage was the Strategic Outline Case which was completed in March 2021. The Outline Business Case stage was submitted at the end of July 2022 which would then lead to the Final Business Case, to confirm the preferred option which is affordable and remains the best value. Each option was appraised against qualitative and quantitative criteria and the Trust Board of Directors have selected Option 2 as the preferred option which is a two-phase development and this option is now being progressed.

There is a separate business case being submitted for a new Energy Centre to be built to ensure there will be sufficient power to the buildings as well as reducing carbon footprint. Approximately 250 - 300 car parking spaces will be lost whilst the building work is underway, but they are looking at options for a multi-storey car park as well as piloting new ways of working.	
The plans for the hospital are required to be approved by the Department of Health and HM Treasury. It is hoped that construction will begin in Quarter 3 early 2024.

13	<ul> <li>SW reported that she had been invited to attend this meeting.</li> <li>Regional/National Updates:         <ol> <li>East Midlands Ambulance Service (EMAS) April - June 2022 monthly reports:</li> <li>LB from EMAS, reported that the non-conveyance rates for the public who do not go to Accident and Emergency were currently around 60%, as 999 calls do not always go there.</li> <li>They are seeing more critically ill patients. Frailty cases have fallen but the non-injured are waiting for a prolonged time.</li> <li>LB reported that he is working within iCAN and is the EMAS representative there.</li> </ol> </li> </ul>	
	LB reported that there are system pressures and that last week Northampton along with Derby and Leicester were in critical incident positions. The numbers of ambulances and lost hours with delays has doubled with trying to get the patients into hospital. If this could be reduced, it would help the CAT 2 and 3 patients. He said there is a skill mix, but now have 50% registered paramedics. They currently have 15 apprentice
